Additional Compensation - Proposition 301 Revenue

Proposition 301 monies are based on estimated revenue from voter-approved taxes for certified compensation and classroom improvement. The estimated revenues per eligible staff member for SY 2008-09 (based on the average for the previous 3 years) is \$6,544.* Of the revenues available, 40% is based on the District's Pay for Performance Program.

**Proposition 301 funding is based on receipt of sufficient funds. If the legislature fails to fund fully, the Governing Board shall reduce the total amount of compensation due to each employee. Please note that this is the reason the amounts are designated as "estimated".*
